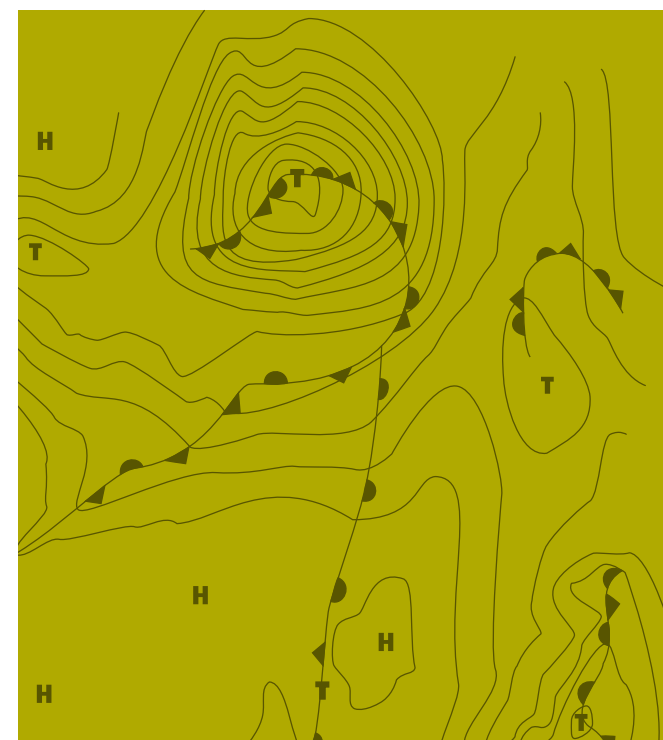

#### **A Critical View about REDD in Amazonia: Controversies on Market Based Solutions**

The «Belem Letter», a document signed by a coalition of Brazilian social and environmental movements and civil society organizations, calls on the Government of Brazil to reject REDD as a carbon market-based mechanism compensating emissions from Northern countries. The critical voices from Brazil refuse a possible inclusion of incentives to monocultures as reforestation or the promotion of industrial logging under the banner of Sustainable Forest Management. The workshop provides a floor for different positions and voices from Amazonia.

#### **Climate Change in Southern Africa: Who Bears the Burden?**

Southern Africa suffers from extreme climate variability and communities, with women at the forefront, have for centuries developed strategies to adapt to its impacts – strategies that could be learned from and replicated. The workshop presents the findings of the study «Gender and Climate Change in Southern Africa» focusing on gender differentiated vulnerability, impacts and responses to climate change in southern Africa. Four case studies were developed under the project in South Africa, Botswana, Mozambique and Namibia respectively. #### **Climate and Trade – Why Climate Change Calls for Fundamental Reforms in World Trade Policies**

Can global warming be kept under the dangerous threshold of 2 °C if current trade flows and world trade policies remain as they are? Over 20 percent of all CO<sub>2</sub> emissions from industrial production arise from products that are internationally traded. In addition, there are the emissions arising from the transportation of these goods. What's more, debate is whether trade rules inhibit the transfer of climate-friendly technologies. Climate policy, it seems, will need to deal with world trade issues – if not in Copenhagen, then soon afterwards. This workshop discusses reforms in both climate and trade policy to tackle the problem.
